Durham School Services has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure effective June 5, 2026. The affected location is Warren County School District, located at 126 Middle School Drive, McMinnville, TN 37110. The total number of affected workers is 79. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 9, 2026.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The Upper Cumberland Local Workforce Development Area rapid response team, employed by the Upper Cumberland Local Workforce Development Board, has been notified to coordinate services with the employer and affected employees. The Upper Cumberland Local Workforce Development Board will be responsible for the oversight of and the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
