First Brands Group, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure effective April 30, 2026. The affected location is TMD Fayetteville located at 11 East Park Dr. Fayetteville, TN 37334. The total number of workers affected is 333 Tennessee employees. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on March 3, 2026

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The Southern Middle Local Workforce Development Board's rapid response team, employed by the South Central Tennessee Development District, has been notified to coordinate services with the employer and affected employees. The Southern Middle Local Workforce Development Board will be responsible for the oversight of and the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
