PMC Biogenix, Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure effective April 26, 2026. The total number of affected workers is 172; 122 of the employees are represented by a union. The affected location

is 1231 Pope Street, Memphis, TN 38108. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on February 26, 2026.

The applicable collective bargaining agreement will govern union-represented employees at the facility, and non-union-represented employees do not have bumping rights. The Greater Memphis Local Workforce Development Area rapid response team, employed by The Greater Memphis Chamber, has been notified to coordinate services with the employer and affected employees. The Greater Memphis Local Workforce Development Board will be responsible for the oversight of, and the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
